



Which of the following emotions best describes how you feel about the election results?




What economic issue would you most like the next President to focus on?




In general, do you think that the federal government is...part of the solution, or part of the problem - for challenges facing you and your family today?

If the federal government had a solution for a major problem facing this country, do you trust the government could implement this solution effectively?



Federal government programs should be subjected to regular performance reviews to ensure they are providing Americans with value for their tax dollars.




Federal regulations should have a “sunset” provision. That is, these regulations should have a date where they either end or Congress decides to renew them.




Now, I would like to read you a list of statements. Please listen carefully as I read each statement and tell me if you would agree or disagree with that particular statement.




Taking action against countries like China that alter the value of their money and hurt American workers even if this meant that some goods would cost more.






Changing federal safety net programs like Medicaid and food stamps to block grant programs where states receive a set amount of money to fund these programs in the way that they think is best.



Imposing an import tax on goods made by companies that moved production factories from the United States to other countries.




Based on your experiences, would you say that you approve or disapprove of Obamacare?

(If "Disapprove" in Q19, Asked of N= 496 Respondents, or 49.6% of Sample)








Health insurers are required to insure everyone who applies for coverage, even if that person is sick now or has had health problems in the past.




Children may stay on their parent's health insurance until they turn 26 years old.



All Americans are required to either purchase health insurance or pay a substantial fine to the federal government.




Health care for individuals is sold through a program run by each state. States provide a system to match insurance plans with customers.





Low income individuals are given subsidies from the federal government to buy health insurance.
